### **Preparing For The Next Y2K Moment**

**Amaravati Quantum Valley Declaration antici**pates a trillion-dollar opportunity. Rest of India

he government of Andhra Pradesh issued the Amaravati Quantum Valley Declaration earlier this week, committing to transform the state capital into a global hub for quantum innovation. The plan includes installing an IBM Quantum System Two by early 2026, building India's largest open quantum testbed (QChipIN), supporting the launch of 100 quantum startups, and training 5,000 specialists annually by 2030. The goal is to test 1,000 quantum algorithms a year and achieve 1,000 effective qubits by

This is a smart move because a trillion-dollar opportunity is opening up.

In the late 1990s, a looming crisis galvanized the Indian technology industry like nothing before: the Y2K bug. As the world braced for computer systems to fail when the calendar flipped to 2000, companies and governments scrambled to fix outdated software written decades earlier. What followed was a windfall for India. Tens of thousands of young engineers, fresh from university or retraining boot camps, stepped in to debug code and modernize systems.

Now, a quarter-century later, the world is headed toward another such moment - a problem of breathtaking complexity, urgency, and scale. Only this time, it won't be about two-digit dates. It will be about quantum computers and their ability to shatter the cryptographic codes that underpin nearly every system we rely on from banking and e-commerce to messaging apps and government databases.

This will be the mother of all Y2Ks. made possible by a radically new type of

computer.

Unlike classical computers, which store data in bits that are either 0 or 1, quantum computers use qubits, which can be 0 and 1 at the same time — a property called superposition. They also take advantage of entanglement, a quantum phenomenon that links particles so the state of one instantly affects the other. These properties allow quantum machines to solve certain problems exponentially faster than classical ones, especially those involving complex patterns or massive search spaces.

At the heart of the current threat lies Rivest-Shamir-Adleman (RSA) encryption, a technology that secures online banking, emails, WiFi routers, and even cryptocurrency wallets. Its security comes from the mathematical difficulty of factoring large prime numbers.

Today's classical computers would take thousands of years to break it. But quantum computers, with their ability to perform parallel calculations at massive scale, could theoretically crack RSA in hours or minutes using an algorithm known as Shor's algorithm - once they reach sufficient scale and stability.

Until recently, this danger seemed comfortably far off. Experts estimated that it would take a quantum computer with 20 million error-corrected aubits. to break RSA-2048 encryption. No one had anything close. But a new study this year showed it might be possible with just one million qubits — a number that suddenly feels within reach.

Google's latest 100-qubit "Willow" chip demonstrated exponential error reduction, a crucial step toward fault-tolerant computing. IBM has already built a 1,121-qubit processor, the Condor, and laid out a roadmap to large-scale, modular quantum systems by 2029. Microsoft is experimenting with topological qubits that could make error correction far more efficient.

These are still early days, but the trajectory feels eerily familiar when you look at what happened with artificial intelligence (AI). As recently as 2020, most people outside a handful of research labs had never heard of large language models.

The idea that a machine could generate essays, summarise legal contracts, create lifelike videos, or simulate entire conversations felt like science fiction. Then came the breakthroughs: GPT-3, ChatGPT, Google Gemini, Claude, and more. Suddenly, AI wasn't decades away

it was everywhere, transforming industries in real time.

The same may be true for quantum computing. We may not see it coming until it is may be too late to react.

demonstrates the ability to break RSA encryption, the world will be thrown into a frenzy. Every secure system will need to be upgraded, digital certificates replaced, encrypted databases reprotected, and network protocols rewritten.

This isn't just a mega IT project, it is a global infrastructure overhaul that will touch every major company, government, and connected device. In complexity, it will make the Y2K bug look small.

To make things worse, most companies are still unaware of what cryptographic algorithms they use, let alone whether they are quantum-safe.

In the Y2K era, Indian engineers-built trust by solving hard problems at scale. Now, with millions of trained coders, hundreds of thousands of cybersecurity professionals, and a rising ecosystem of quantum researchers, cryptographers, and startups, India is better prepared than any other nation to take the lead.

İmagine what will happen when a global quantum alert is triggered — when banks, telecom companies, and governments race to upgrade their cryptographic systems. They will need trusted partners who can move fast, understand both legacy software and next-gen cryptographic libraries, and operate across borders.

India needs to have ambulances and fire trucks ready — training a new generation of software developers in postquantum cryptography, upgrading tools, contributing to open-source frameworks, and preparing global response teams.

That is why the Amaravati announcement matters. If the rest of the country follows Andhra Pradesh's lead — investing in talent, infrastructure, and startups - India can save the world

### **US Designates Pahalgam Attackers As Terrorist Organization**

he United States has designated The Resistance Front as a Foreign Terrorist Organization (FTO) and Specially Designated Global Terrorist (SDGT).

The State Department announced the action July 17, saying, "TRF, a Lashkar-e-Tayyiba (LeT) front and proxy, claimed responsibility for the April 22, 2025, Pahalgam attack which killed 26 civilians, adding that, "This was the deadliest attack on civilians in India since the 2008 Mumbai attacks conducted by LeT. TRF has also claimed responsibility for several attacks against Indian security forces, including most recently in 2024."

These actions taken by the Department of State "demonstrates the Trump Administration's commitment to protecting our national security interests, countering terrorism, and enforcing President Trump's call for justice for the Pahalgam attack."

The US House Foreign Affairs Committee Majority on Saturday said President Donald Trump strongly backed the administration's decision to designate The Resistance Front (TRF) as a Foreign Terrorist Organization, calling it a deserved move

against those responsible for killing civilians in India, ANI reported.

'President Trump calls it like it is. The Resistance Front is a foreign terrorist organisation and deserves the designation. When you butcher civilians, you don't get a pass-you get JUSTICE," the Committee posted on X.

TRF and other associated aliases have been added to LeT's designation as a FTO and SDGT pursuant to section 219 of the Immigration and Nationality Act and Executive Order 13224, respectively. The Department of State has also reviewed and maintained the FTO designation

Amendments to FTO designations go into effect upon publication in the Federal Register.

India's Minister of External Affairs S. Jaishankar responded on X, calling the terrorist designation my Washington, "A strong affirmation of India-US counter-terrorism cooperation. Appreciate @SecRubio and @StateDept for designating TRF—a Lashkar-e-Tayyiba (LeT) proxy—as a Foreign Terrorist Organization (FTO) and Specially Designated Global Terrorist (SDGT). It claimed responsibility for the April 22 Pahalgam attack. Zero tolerance for Terrorism. #OpSindoor"

# Trump Says India Trade Agreement Is Close, Europe Deal Possible

he United States is very close to a trade deal with India, while an agreement could possibly be reached with Europe as well, but it is too soon to say whether a deal can be agreed with Canada, President Donald Trump said in an interview aired on Real America's Voice on Wednesday, July 16.

To press for what Trump views as better terms with trading partners and ways to shrink a huge U.S. trade deficit, his administration has been negotiating trade deals ahead of an August 1 deadline, when duties on most U.S. imports are due to rise again.

"We're very close to India, and ... we could possibly make a deal with (the) EU," Trump said, when asked which trade deals were on the horizon.

Trump's comments come as EU trade chief Maros Sefcovic was

headed to Washington on Wednesday for tariff discussions, while an Indian trade delegation arrived in Washington on Monday for fresh talks

"(The) European Union has been brutal, and now they're being very nice. They want to make a deal, and it'll be a lot different than the deal that we've had for years," he added

Asked about the prospects of a deal with Canada, which like the EU, is readying countermeasures if talks with the U.S. fail to produce a deal, Trump said: "Too soon to say."

His comment was in line with the assessment of Canadian Prime Minister Mark Carney, who said earlier on Wednesday that a deal that works for Canadian workers was not yet on the table.

Trump also said he would probably put a blanket 10% or 15% tariff on smaller countries.

### **Assemblywoman Dr. Jasmeet Bains Declares Run For US Congress** From California's 22nd District

amily physician Dr. Jasmeet Bains announced her campaign for Congress from California's 22nd District, July 16, 2025, pledging to bring new leadership if she wins in the 2026 general elections. She accuses Washington D.C. of often ignoring the Central Valley.

'I'm a doctor, not a career politician — and I've spent my life on the frontlines, listening to Valley families and fighting for their health, their safety, and their future,' Bains said in a press release declaring her candidacy. "I'm running for Congress because we deserve better than broken promises and backroom deals, and our communities are tired of getting left behind. We deserve a representative who will actually show up, and stand up, for the Valley.'

Dr. Bains is a family and addiction doctor who serves as the Central Valley's Chief Medical Officer for the California Medical Assistance team, which organizes emergency health services across the state.

Raised in Delano, the daughter of immigrants, and the first in her family to become a doctor, Dr. Bains represents the Kern County area in the State Assembly.

She was elected to the State Assembly in 2022 with strong bipartisan support. She is an advocate for underserved communities and rural healthcare, as well as an experienced physician in the field of addiction and the fentanyl crisis.

To date three candidates are in the running for the House seat in the Nov. 3, 2026 election. The incumbent is Republican Rep. David Valadao, who, she says has voted for gutting Medi-Cal, slashing food assistance, and

backing a budget that she says would devastate working families in the Central Valley. Valadao has been in Congress from 2013 through 2019, and then 2021 to the present. The two Democrats on the ballot so far are Rudy Salas and Randy Villegas.

The Cook Political Report and Larry J. Sabato's Crystal Ball both rate District 22 and leaning Republican. Valadao won the 2024 elections with a 7 percent lead

over his Democratic opponent Rudy Salas.

CA-22 includes Bakersfield, Delano, Hanford, and communities across Kern, Kings, and Tulare Counties one of the most diverse regions in California.

"For too long, politicians in both parties have treated the Central Valley like an afterthought," Dr. Bains says, "I'm running to change that — because this district is my home, and I'll never stop fighting for it.'

Dr. Bains is a two-term California State Assembly member who represents District 35. She is a graduate of Illinois Institute of Technology in biology, and earned her medical degree from the American University of


Dr. Bains completed a primary care psychiatry fellowship at the University of California-Irvine in 2019.

Her career experience includes working as a physician at Clinica Sierra Vista in Bakersfield and Omni Family Health and as a medical director of Bakersfield Recovery Services, her biography on the campaign website, dr.jasmeetbains.com says.

Bains volunteered with the California Academy of Family Physicians and the California Medical Association. She was the chair of the California Healthcare Workforce Policy Commission for the Office of Statewide Health Planning and Development and a volunteer physician for the Central Valley Unit Medical Team for the State of California's Emergency Medical Services

Authority.
In the State Assembly, she is credited with securing \$20 million to fight fentanyl addiction and drug trafficking, and led an effort to build a University of California medical school in Kern County.

She was named Legislator of the Year by CalPACE, the Alzheimer's Association, and Crime Victims United; honored by the American Sikh Council for breaking barriers; and recognized as Physician of the Year by the Kern County Black Chamber of Commerce.

### Rep. Jayapal Introduces Bill To Prevent **ICE From Detaining U.S. Citizens**

S. Representative Pramila Jayapal (D-Wash.), Ranking Member of the Subcommittee on Immigration, Integrity, Security, and Enforcement, has introduced legislation that seeks to prohibit federal immigration authorities from arresting, detaining, or deporting U.S. citizens. The proposed legislation—titled the Stop ICE from Kidnapping U.S. Citizens Act—aims to address a series of cases in which citizens have allegedly been unlawfully detained by Immigration and Customs Enforcement (ICE).

Jayapal called the move long overdue, citing what she describes as a pattern of misconduct by ICE, particularly targeting Latino and immigrant communities. "ICE is acting like a rogue force, kidnapping and disappearing people off the streets with no due process," Jayapal said in a statement. "When ICE is conducting immigration enforcement, arresting and detaining U.S. citizens is illegal — and deporting U.S. citizens is illegal, full stop.'

The bill seeks to codify existing legal protections and hold immigration agents accountable for violating them. It would also establish penalties for agents found to have unlawfully detained or placed citizens into immigration proceedings.

Among other positions, Dr. Shah was a Senior Advisor to US Surgeon General; She served as a Fellow and special advisor to the Secretary of Veterans Affairs serving as the first National Director of Clinician Wellbeing. She has also served in the private sector.

District 7 in New Jersey is among the most competitive districts according to news reports, and the Shah may face an uphill battle ousting the other Democrats running for the seat.

# Axiom-4 Mission: A Saga Of 12 Million Kilometers And 282 Orbits Aboard ISS

July 15, 2025:

he Axiom-04 mission has successfully concluded with the return of ISRO Gaganyatri Shubhanshu Shukla, marking a proud moment both for ISRO and India as he returned after a historic 18-day scientific mission aboard the International Space Station (ISS). Launched on June 25, 2025, aboard the SpaceX Dragon spacecraft, the mission was conducted in collaboration with NASA, Axiom Space, ESA, and other international partners.

During his stay aboard the ISS, Shubhanshu Shukla adapted exceptionally well to the microgravity environment. Despite the physical and psychological challenges of spaceflight, he maintained optimal health throughout




Astronaut Shubhanshu Shukla with the Indian National Flag flying high on board the International Space Station.

in India's space diplomacy.On July 03, 2025, Gaganyatri Shubhanshu Shukla interacted with school students from Trivandrum and Lucknow through a video link, where he answered many questions on how to become an astronaut and life onboard the International Space Station

This was followed by two Amateur Radio on the International Space Station (ARISS) sessions that enabled real-time conversations with school students. The first session was held on July 4, 2025, with students and engineers at URSC, Bengaluru, where Shukla fielded questions on life in space, daily routines aboard the ISS, and the significance of scientific research in microgravity. The second session, conducted on July 8, 2025, connected students from seven schools in Northeast India through a coordinated link with NESAC, Meghalaya, providing them with a rare opportunity to speak directly with an Indian astronaut in orbit.

On July 6, 2025, Shukla also held a teleconference with the Chairman of ISRO, updating him on the progress of

the mission. He captured a wide array of photographs and videos documenting life and work in orbit.

#### ISRO-LED SCIENTIFIC EXPERIMENTS COMPLETED

Gaganyatri Shubhanshu Shukla completed a suite of seven microgravity experiments developed by Indian research institutions under the Human Space Flight Centre's (HSFC) coordination. These experiments explored muscle regeneration, algal growth, crop viability, microbial survivability, cognitive performance in space, and the behaviour of cyanobacteria—each aimed at enhancing understanding of human spaceflight and microgravity science. The experiments are

uting to the daily rhythm of ISS operations and supporting joint science, maintenance, and outreach efforts. He participated in integrated crew timelines, shared resources aboard the Harmony module, and coordinated multiple crossover activities, fostering international cooperation in space.

#### **PUBLIC ENGAGEMENTS**

Axiom-04's public outreach component was an integral part of the mission, connecting India's space achievements with its citizens and students. These events underscored the importance of inspiring the next generation while celebrating national pride.

On June 28, 2025, Gaganyatri Shubhanshu Shukla participated in a historic live interaction with Hon. Prime Minister Narendra Modi from aboard the International Space Station. During the conversation, the Hon. Prime Minister commended Shukla's contribution to India's space journey and spoke of the pride the nation feltin seeing its flag represented in orbit. The broadcast reached millions across India and marked a symbolic milestone

the Indian science payloads and sharing preliminary observations. The exchange reinforced the strong operational link between ground teams and the astronaut, ensuring real-time alignment of mission objectives.

These engagements not only enhanced visibility of the mission but also served to bridge the gap between India's space program and its young aspirants, creating lasting inspiration across generations

#### FINAL MISSION PHASE EVENTS

The formal Farewell Ceremony for the Ax-04 crew was conducted aboard the ISS on July 13, 2025, at approximately 19:25 hrs. IST.

Expedition 73 crew members and mission control teams expressed appreciation for the collaborative efforts and marked the occasion with symbolic gestures of international friendship, including commemorative mission patches and final photographs in the Harmony module.

Following the ceremony, the crew proceeded with hatch closure and vehicle ingress, and the SpaceX Dragon spacecraft undocked from the ISS later on 14 July 2025 at 16:45 hrs. IST, beginning its return journey to Earth. The undocking was carried out with nominal systems performance, monitored by NASA and Axiom Space flight controllers in coordination with SpaceX's MCC-X in California.

After an Earth-orbiting free flight lasting nearly 22 hours and 30 minutes, the splashdown of Dragon occurred successfully on July 15, 2025, at approximately 15:03 hrsIST in the Pacific Ocean, off the coast of California. The capsule was recovered promptly by SpaceX's recovery teams, and Shukla was extracted in stable condition. The mission concluded with nominal deorbit operations and vehicle performance.

In addition, Bhagavata Saptaha, a week-long discourse on the divine Srimad Bhagavad Gita in Telugu was conducted by Sri

The Gt Utsav 2025 marked a historic milestone as the largest Bhagavad Gt-centered gathering in U.S. history. More than 500 memorizers and 500 fluent readers from the 2025 graduating batch of the Gt Mah Yajña program joined thousands of alumni to recite the Gt in unison, filling the auditorium with spiritual energy and

This year also commemorates the 10th anniversary of the Gt Mah Yajña program, envisioned in 2015 by Sri Swamiji. What began with a handful of memorizers has now grown into a global movement: over 7,000 have memorized the Gt in full, and more than 10,000 are fluent readers world-

The organizers explained that participants typically memorize the entire Bhagavad Gt in just 10 months. He extended special gratitude to Gt Coordinator Srikanth Challa and the teaching staff for their unwavering com-



# Can You Travel Internationally This Summer? Key Advice for Immigrants in the U.S. By David H. Nachman, Esq

Summer is a popular time for vacations, but for immigrants in the United States, international travel comes with additional risks and responsibilities. Whether you're here on a visa, a green card, or you're a naturalized U.S. citizen, it's important to understand what to expect before leaving—and when trying to return.

#### Traveling on a Nonimmigrant Visa? Be Extra Cautious

If you're in the U.S. on a nonimmigrant visa such as B-1/B-2 (tourist), F-1 (student), or H-1B/L-1 (work), remember: entry to the U.S. is never guaranteed. Customs and Border Protection (CBP) officers at ports of entry have broad discretion to inspect your documents, your phone, and your reasons for travel. Red flags—like missing information about where you'll stay or questionable content in your phone—can result in denied entry, visa revocation, or even detention.

#### Tips for nonimmigrant visa holders:

- Always travel with proof of your return plans (e.g., roundtrip ticket).
- Be prepared to show a valid reason for your stay and a place to stay in the U.S.
- Never misrepresent yourself or hide past activities—especially political or employment-related.
- If you're a student, make sure your SEVIS record is active, and travel with financial proof and school documents.
- If you've worked without authorization, even briefly, reconsider traveling.

#### H-1B Workers: Prepare Your Employer and Carry Documentation

H-1B visa holders should ensure their employment remains in good standing while abroad. CBP may contact your employer to verify job details—even while you're in transit.

#### Best practices

- Let your employer know your travel dates.
- Carry a recent employment verification letter.
- Travel with pay stubs and an updated I-797 approval notice.
- If you're going for visa stamping, confirm your job and documents are in order.

#### Green Card Holders: Travel Only If You're Certain It's Safe

Lawful permanent residents (green card holders) must be especially cautious if they have any past criminal history, even minor offenses from years ago. Certain charges can trigger detention or loss of status—even if they happened decades

Before you travel:

- Talk to an immigration attorney if you have any criminal record (e.g., DUI, theft, fraud).
- Don't sign anything at the airport—such as Form I-407 to abandon your status—without legal advice.
- If you've been outside the U.S. for more than 6 months, bring documentation showing your ties to the U.S.
- For trips over 12 months, you'll need a re-entry permit or possibly a returning resident visa.

As a U.S. citizen, you have the right to re-enter. But CBP can still inspect your phone, question you, or detain you briefly for additional screening. You don't have to unlock your phone or provide passwords, but prepare for possible delays.

- Avoid carrying devices that contain sensitive or questionable content.

### The Hunt Is A Gritty, Gripping Procedural Narrative

he real-life assassination of India's premier, Rajiv Gandhi, in May 1991, shook and shocked the nation.
After a grueling investigation, the coterie of culprits was caught. Happily, no corrupt cop was involved, though there was incredible red tape for such a prestige probe, especially towards the end of the investigation.

The story has been documented in a book named Ninety Days: The True Story of the Hunt for Rajiv Gandhi's Assassins, by Anirudhya Mitra, and that forms the background of this 7-episode series named The Hunt: The Rajiv gandhi Assassination Case. Procedural dramas, even in fiction or cinema, tend to be by nature plodding and stretched, and this one is no different.

The series is made for obvious reasons in both Hindi and Tamil, as the backdrop was Tamil Nadu and the culprits were affiliated to LTTE (The Liberation Tigers of Tamil Eelam, also known as the Tamil Tigers, a militant organization that fought for Tamil Eelam, a separate state in the north and east of Sri Lanka). The

Tamil accents even for the Hindi version makes things authentic but quaint, but one wishes still that the docu-drama was speeded up.

Amit Sial plays the leader of the team, D.R. Kaarthikeyan, with aplomb, and heads a team of doggedly diligent police officers who put together the pieces of the puzzle with grit and rare integrity. Sleepless nights, sudden failures, official criticism from the powers above, clashes with the Tamil Nadu police—the

obstacles are many and humongous. But they scythe through all these and come up trumps, nailing the one-eyed mastermind, Sivarasan (Shafeeq Mustafa), but sadly not alive. However, Anjana Balaji as Nalini, Sai Dinesh as Murugan live to tell the tale of how things were set in place, apart from what was found out from interrogations of others and evidence that came in, sometimes through lucky breaks. The dry run conducted a fortnight earlier on Prime Minister V.P. Singh remains a chilling truth

and is not known to many, though.

While the screenplay is leisured, the actors are all brilliant. Kaarthikeyan's core teammates, Amit (Sahil Vaid), Amod Kant (Danish Iqbal), Ragothaman (Bagavathi Perumal), Radhavinod (Girish Sharma) and Ravindran (Vidyut Garg) are precise and hit the bull's-eye in their sharply delineated characters. The 'baddies' are no less. Sivarasan (Shafeeq Mustafa) is outstanding, while Anjana Balaji as Nalini and Sai Dinesh as her husband Murugan score high, especially in the jail sequence where Ravinder tricks them into a confession. Yes, the police torture scenes tend to become a shade repetitious.

Technically, the series is state-of-theart and the most brilliant aspect of it is Sangram Giri's cinematography, which reproduces the feel (as expressed in films of that era) of the early 1990s. Tapas Relia's background score is excellent.

The script (Rohit G. Banawlikar, Nagesh Kukunoor and Sriram Rajan) and direction are first-rate. Kukunoor gets everything pitch-perfect and is in his element yet again after many great movies and the classic series, City of Dreams.

Another ace from SonyLIV, this one.

# Tanvi—The Great Makes It To List Of Best Movies On Persons With Disabilities

ost movies on protagonists with disabilities tend to be successful. But that is the commercial viewpoint, which is valid because exposure to understanding diverse such ailments (some rare) is a must even in 2025 India where ignorance and social stereotyping still thrive. And without entertaining the audience enough to work at the box-office, such enterprises, however diligently made, are fruitless. Example: if a film is to be made on staying on in one's motherland, it should be as heartfelt as Naam (which hit the jackpot), not as boring and unrealistic as Swades(which flopped)

Weeks ago, we watched the brilliant Sitaare Zameen Par, the spiritual sequel to another masterly film, Taare Zameen Par. And now, making a gigantic evolution as filmmaker and writer, Anupam Kher directs a sensitive, sensible, thought-provoking motion-picture experience named Tanvi—The Great. Thankfully, it joins a fairly long and illustrious list that also comprises Koshish, Iqbal, Black, Barfi! and Hichki. And if Jagga Jasoos, Sparsh and Khamoshi—The Musical did not make it, there were individual-specific reasons for it, again in the crucial department of audience appeal.

Tanvi... centers around Tanvi (Kher has taken inspiration from real-life niece, Tanvi, who is an autistic and features prominently in the post-climax, along with his mother Dulari, all of 97 today, and brother Raju Kher). The reel Tanvi here is essayed by his student, (in his academy, An Actor Prepares) Shubhangi Dutt, who can be described by the French as c'est magnifique. If she does not win an award, it will devalue the award and not her.

Shubhangi has apparently spent a fortnight with the real Tanvi and had been instructed by Anupam to "observe her soul" rather than mimic her. And what she has achieved will last her a lifetime as an understanding actor and an evolved human being. Every expression, gesture, movement and reaction seem to have come from someone who must have lived an autistic person within here for the duration of the film's making!

The story is set between Delhi and Lansdowne, a hill resort where there is also a military base in Uttaranchal. Tanvi is Vidya Raina (Pallavi Agnihotri)'s autistic daughter, and her husband, Captain Samar Raina (Karan Tacker) had died in an enemy explosion, on the way to realize his dream of hosting the Tricolor at Siachen, the world's highest battleground.

When Tanvi's mother has to attend a lo-o-o-ong convention (the only hyperbole element in the story, and avoidable at that!) on Autism in New York, the 'burden' of looking after Tanvi falls on Samar's grandfather, Col. Pratap Raina (Anupam Kher), a widower now who lives alone in Lansdowne. Pratap initially does not understand Tanvi and almost wants Vidya to cancel her trip so that he is not left alone to look after her. But Vidya predicts that he will come to understand her slowly, and her prediction is not just bang-on but comes true beyond expectations!

As Tanvi, who makes friends pronto, wins over not just her grandpa but also

her music teacher there, Raza Saab (Boman Irani) and Brigadier Joshi (Jackie Shroff), she also discovers her father's unrealized dream (she was 7 when he died) of hoisting the Tricolor at Siachen after foraging through his room (which has been lovingly preserved by Pratap).

Her only dream now is to fulfil that, but there are two obstacles: she has to join the Army, as only their personnel can go there, and the Army does not allow autistics in the force! And now, despite reasoned discouragement from her grandfather, Tanvi begins and completes her military training and appears for the interview. What happens next?

The thrill element at the end becomes a shade less in impact because of the Utopian end and a slight excess in length. But for a message film like this, the rather implausible climax can be overlooked.

Anupam Kher and Jackie Shroff (both especially), Pallavi Joshi, Boman Irani (totally charming in his demeanor), M. Nassar (in the recruiting interview), Arvind Swami, Gautam Ahuja as Joshi's son and Devender Madan as Joshi's mother strike home in their performances along with Iain Glen and Ashish Kauhsik in smaller roles

The script is heartfelt, the dialogues wonderful (Kher with Ankur Suman and Abhishek Dixit) and the production values superb. Kher's direction is passionate and if it can be faulted at all, it is in the underuse of the brilliant songs of M.M. Keeravani and the spot-on lyrics of Kausar Munir. It is to the writers' credit that the written word does not resort to melodrama and yet stirs our emotional chord. The background score too is perfect.

Watch this film for its passion, its magic and the takeaways.

# Remembering A Musical Legend: Salil Chowdhury Left An Indelible Mark On South Asian Culture

he legendary Indian music composer Salil Chowdhury 'completes' 100 shortly. 'Salilda', as he is fondly known, was born in a village in West Bengal on 19 November 1925; he left on 5th November, 1995. On his passing away at 69, Lata Mangeskar grieved thus: "I could not do more for Salil Chowdhury", highlighting respect she had for Salilda! Salilda-Latadidi combination of "na jeona" (Bengali) or "o sajana" (Hindi) from the film Parakh remains amongst my all time favourites.

Salilda was deeply influenced by Tagore; on Tagore's death on 7 August, 1941, Salilda cried! Salilda said: "that was the first time in my life that I consciously felt the loss of someone close to me! I went into mourning....I used to come to College barefoot...I did not eat fish or meat."


Salil Chowdhury was known for his socially conscious music addressing social justice. This aligned with world saint Swami Vivekananda's philosophy of addressing societal issues. So, Tagore's and Swamiji's influence on Salil Chowdhury is evident.

#### **FUSION OF WESTERN AND INDIAN MUSIC**

Salilda's unique contribution is fusion of Western and Indian music. This made him a world music composer. When I sang "old Hindi film melodies" in August 2010 in Kathmandu on the invitation of my friend Rakesh Sood, then India's High Commissioner in Nepal, the moment I started "Zindagi kaisi hai paheli haye" the 1000-strong audience in the packed Army Auditorium clapped in unison. In the SAARCLAW conference in Dhaka in December 1996, barely a year after Salilda left, I noticed huge respect for Salilda; same in Karachi in the SAARCLAW conference that I attended in February 2004. Salida has left an indelible mark on South Asian culture.

So, Swami Vivekananda, Rabindranath Tagore and Salil Chowdhury constitute world saint, world poet and world music composer respectively, India's contribution to soft power.

Salil Chowdhury spent his childhood in the tea gardens of Assam. His father, Dr.Gyanendra Chowdhury, was a medical officer in a tea estate. Though Salilda's mother was not a musician, she greatly encouraged her child. So did Salilda's father who had a collection of westerns

classical songs of singers like Bach (1685-1750) from Germany, Mozart (1756-1791) from Austria, Beethoven (1770-1827) from Germany, and even Chopin (1810-1849) from Poland. Exposure to Western classical music greatly influenced Salil Chowdhury. He used to listen to western orchestral music in gramophone of Dr.Maloni, an Irish national, who was the chief medical officer of the tea estate.

World War II (1.9.1939-2.9.1945) and the Bengal famine (1943) devastated Salilda. He was still in his late teens then, having joined Bangabasi College, Sealdah in Kolkata. The British diverted food supplies from Bengal. Salilda witnessed millions dying on the streets of Kolkata during famine. He protested. And became a member of IPTA (Indian People's Theatre Association), an association of artists, to bring cultural awakening in India. Some of the prominent initial members of IPTA were Prithviraj Kapoor (1906-1972), Balraj Sahni (1913-1973), Pandit Ravi Shankar (1920-2012), Ritwik Ghatak (1925-1976) and Salil Chowdhury (1925-1995). Even Shailendra (1923-1966), the legendary lyricist, joined ITPA; IPTA gave a fillip to the Quit India movement launched by Mahatma Gandhi on 8 August 1942.

#### **BOLLYWOOD BREAK AND PATH-BREAKING FILM**

After India's independence, Salilda continued with his musical passion in greater vigour. His best friend, filmmaker Hrishikesh Mukherjee (1922-2006), brought Salilda and film director Bimal Roy (1909-1966) together. Bimal Roy gave Salilda the biggest break of his life. Salilda entered Bollywood in the film "Do Beegha Zameen", released on 16 January, 1953.

The film portrayed peasant exploitation in West Bengal. Salilda's role in the film was not only as a music composer, but also as the script writer of a short story "Rickshawala"; Roy enmeshed Salilda's "Rickshawala" and Tagore's "Dui Bigha Jomi" to convert them into a path-breaking film. The film remains a trendsetter. It became the first film to win the Filmfare Best Movie award, and the first Indian film to win an international award. It took Salil Chowdhury's career to new heights.

#### A MUSICAL GENIUS AND GURU

Salilda was 27 when he achieved this break in 1952-53. Till his last day he never looked back. He composed music in 143 films, 75 of them in Hindi, 41 in Bengali and 27 in Malayalam. Besides, he composed music in 13 languages. He was adept at playing flute, piano, esraj and harmonium.

Both Rahul Dev Burman (1939-1994) and Hriday Nath Mangeshkar considered Salilda as their musical guru. When in creative or personal distress, R.D.Burman often turned to Salil Chowdhury for guidance, despite being the son of the legendary S.D.Burman.

From my boyhood in Calcutta from 1961 onwards I used to hear "Anurodher Asor" every Sunday afternoon. I used to give marks to each song; I must say that two songs made me weep everytime I heard them. They are both Salida and Latadidi combinations: first: "O Bansi keno gaye amare kandaye" and second: "Jare Jare Ude Jare Pakhi"! As I write, droplets fall from my eyes. Salilda is immortal!

### Nikita Roy Sees Sonakshi Sinha In Superb Form

s a film, it is better than good, and as a first film of a director, it is better than even that. To the point, sans melodrama, sans gimmicks, following a genre and yet not suffused with tropes, Nikita Roy is a clever piece of entertainment that balances manoranjan with craft as well as a social comment.

Spiritual leader Amardev (Paresh Rawal) has a loyal clientele and followers in London, but Sanal Roy (Arjun Rampal) of the Rationalist Society suspects that all is not above board. He plants Freya (Kallirroi Tziafeta) there as a follower and plans to expose the man. However, before he can do that, he dies an untimely death, after ghastly and ghostly things happen to him.

His sister, Nikita Roy (Sonakshi Sinha), devoted to him and then in India, is summoned to London. She point-black refuses to believe that his death was either an accident or suicide, and when Sanal's colleagues in the Society dissuade her from investigating Amardev, begins her own inquiries, aided by Sanal's friend who has also always loved her, Jolly (Suhail Nayyar).

The first stop is obviously Freya's far-out cottage, but in front of them, the seemingly-possessed girl slits her own throat. It is now time for Nikita to confront Amardev, who coolly tells her that she has just three days to live when Nikita threatens to expose him within a week.

So what is the mystery's solution? Is it Amardev doing something in the occult department? Is there more? What evil force acted on Sanal and Freya and has now begun to act on Nikita too?

A tight under-two hours thriller, Nikita Roy is a vast im-

provement on recent (coincidentally) UK-based thrillers revolving around heroines (Savi, Ulajh, The Buckingham Murders) in terms of story and content. It has a neat plot, without loose ends or loopholes, and the only weakness is that the denouement, though sensible, is too hasty and possibly a tad complicated for the layman. In this matter, the scriptwriters including the director err significantly for the Indian audience.

Except for this, Kussh S. Sinha's debut as a director is easily among the brightest ones this year. The cinematography (Anshul Chobey), production design (Sunil Nigvekar) and editing (Ritesh Soni) are of high standards, and the BGM (Amar Mohile) is better than Mohile's normal over-the-top standards.

The script is tight, devoid of cliches, and the dialogues sharp and to the point. As always, the songs are forget-table.

Sonakshi Sinha is absolutely fantastic in the title-role and Paresh Rawal, sorry to employ the contrasting word, is divine! Arjun Rampal and Kallirroi Tziafeta score high, and Suhail Nayyar is perfectly in-sync as Jolly.

In a milieu where overconfident producers have under-promoted the film, one wishes that this movie had released directly on OTT. It deserved much better than the reception it is likely to get and could have been another Jaane Jaan (2023) in terms of audience viewership as well as critical acclaim.


